 - 2. To vote for support or non-support of route E1.
 - 3. To vote for support or non-support of route E2.
 - 4. To vote for support or non-support of the HSR project regardless of routes.
 - 5. To vote to write and submit a CIS by SVANC to the City Clerk's office with the voting results.
