- ITEM 8: Discussion / Motion / Vote to send a letter to Council Members Nury Martinez & Paul Krekorian and Foothill Police Chief Grimes requesting to add five additional police cars with two officers each for extra patrolling of Sun Valley on the evening of July 3-4-5 from the hours of 4PM to 1AM (with one hour lunch) to stop people with illegal fireworks by giving out tickets and confiscating fireworks. The money to pay for this should come from Monies in Waste Facility Trust Funds of Athens Services and Sun Valley Paperstock. There should also be a portion of the Street Furniture fund that should be allocated to Sun Valley. THIS IS A MAJOR PROBLEM for RESIDENTS and domestic animals in Sun Valley and throughout the San Fernando Valley.

This workshop was rescheduled and presently booked at Holy Rosary Church for August .1 If the Pandemic does not allow for the gathering, we will continue to find a date when it can be held.

A great deal of work has already been performed on this workshop. 97 people, who have been prescreened, have prepared their papers and were notified that August 1, 2020 was the date that our volunteers and the International Rescue Committee (IRC) will be prepared to help them fill out their Citizenship applications. This service saves these people a great deal of money for lawyer fees.
