SLO Lindsey, LAPD: Crime is down in Sun Valley. The annual Fitness Run that benefits Foothill Area kids will be held on Saturday, May 19, 2018. There will be an Active Shooter Training at CPAB on Thursday April 12, 2018. There are still openings available. There has been a lot of mail theft and "Porch Pirates" stealing packages in the Sun Valley area.

Neighborhood Prosecutor Ross, City Attorney's Office: Mr. Ross had stated that he had attended one of the active shooter trainings and felt it was beneficial for the community and encouraged everyone to attend. Mr. Ross discussed the illegal dumping on Peoria and that there is a task force working with Public Works to stake out the area and catch people in the act of illegally dumping. Two suspects were recently caught in the act of illegal dumping. One suspect was cited and released while the other suspect was arrested and charges filed. The second suspect has pleaded guilty, spent thirty days in jail, and was required to pay fines that totaled \$4,000.00. Ms. Duenas inquired as to what types of items are being dumped. Mr. Ross said that it is mostly construction material. Mr. Khalaf asked why when there are active incidents in schools, such as active shooter are the police slow to release the children back to their parents. Mr. Ross stated that the scene has to be secured and some of the suspect(s) may mingle with the students and it takes time to sort the children out at the scene.

FD Lorraine Diaz, Office of Council Member Paul Krekorian. Ms. Diaz talked about the recent Homelessness Town Hall sponsored by the Council Office. Video of the town hall is available on their website. Ms. Diaz also provided booklets on who to call in regards to homeless services. The Arbor Festival will be held on Saturday, April 28, 2018 at the Victory/Vineland Recreation Center. The event will be planting trees all of the way up Vineland with a selection of free trees will be available to the public to take home. See flyer available on the back table.

FD Caesar Huerta, Office of Council Member Nury Martinez: The Council Office will be sponsoring tree planting on Earth Day. See flyer available on the back table. There has been an upswing of rogue cannabis shops setting up shop in the Sun Valley area and the Council Office is keeping a list of those locations so that the Council Office and LAPD will be ready to move forward on enforcement once the procedures of handling illegal operations is approved. Sun Valley currently has eight cannabis operations that are operating illegally and four that are compliant.

NEA Kathleen Quinn, Department of Neighborhood Empowerment: Substituting for NEA Betty Wong tonight. Ms. Quinn congratulated the SVANC on their EmpowermentLA Award. The Department hoped all in attendance at the awards ceremony enjoyed the event. The Congress Planning Committee is looking for volunteers to help plan the event. Equity Funding Group continues their citywide meeting tomorrow night in Boyle Heights.
