SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible

legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

- (C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.
- (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.
- (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

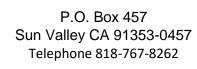

The Sun Valley Area Neighborhood Council, SVANC, in its regular meeting of September 10, 2024, passed the following community impact statement by a vote of: ? yes, ? no, ? absent, ? recused, and ? ineligible.

The Sun Valley Area Neighborhood Council strongly supports CF 23-0914, which proposes to instruct the Chief Legislative Analyst and City Administrative Officer, with the assistance of the City Attorney, Department of Transportation, LA Sanitation and Environment, Department of City Planning and other relevant departments, to report back with recommendations for a citywide program that would restrict oversize vehicle dwelling in residential areas, commercial corridors and other sensitive uses, while designating streets where oversize vehicle dwellings can park with access to services, including housing navigation, portable restroom facilities, automotive repair and septic tank waste disposal. Departments should report back on the feasibility of the following:

- Locations in each Council District where oversized vehicle dwellings can park on the public right of way, outside of residential areas, and commercial corridors and other sensitive uses
- A permit requirement, free of charge, to participate in the program
- Provision of shower and restroom services, similar to the City's Mobile Pit Stop/Shower
 Stop Program
- Regular sanitation services, including waste disposal and trash collection
- Provision of wrap-around services and safety
- Changes to the Los Angeles Municipal Code that may be required to create said program

In 2005, 1,500 acres in Sun Valley were designated as an environmental justice area. This area included parts of Council Districts 2, 6, and 7. In addition, this land is entirely zoned for industrial uses that is very close to residential areas. Therefore, SVANC requests that this environmental justice zone be included in the list of restricted areas for oversize vehicle dwelling.

In addition, Sun Valley is made up of over 20% industrial zone. Many businesses in these areas have also been significantly impacted by the increasing number of oversize vehicular dwellings that create dangerous conditions and nuisance for businesses and their customers. Public property is constantly vandalized. There is ongoing power line and copper theft. Several fires have occurred in these areas.

The Sun Valley Area Neighborhood Council is very familiar with the impact of oversize vehicle dwelling in all areas of our community; therefore, SVANC wants to **include industrial zones and environmental justice zones in the list of restricted areas for oversize vehicle dwelling.**

The Sun Valley Area Neighborhood Council **opposes CF 21-0329-S5**, which will make the implementation of LAMC 41.18 unnecessarily and unreasonably complicated and needlessly involves county agencies in city policy. SVANC believes in the protection of sensitive use sites and deems this Municipal Code section to be a necessary tool for combatting the proliferation of homelessness and protecting health and safety citywide.

LAMC 41.18 is a tool to protect sensitive sites such as schools, parks, libraries, daycare centers, senior centers, and public places while providing interim housing and services to the unhoused. It was not intended to be used to solve the homelessness issues. Sun Valley has over 16 school that have benefited from the implementation of LAMC 41.18. Although encampments continue to come back to our parks, the number of those has decreased and many of the unhoused have received services and taken shelter.

Sun Valley has many industrial areas that given the nature of the locations, they make it suitable for encampments and vehicular dwelling to grow together with illegal activity. SVANC would like LAMC 41.18 to be stronger and to include more areas where the safety of customers and employees is jeopardized.

According to the Chief Legislative Analyst, "LAPD believes that LAMC Sec. 41.18 and its subsections have an overwhelmingly positive impact on public safety" (5/31/24 CLA Report in related CF 21-0329-S4). Therefore, the Sun Valley Area Neighborhood Council strongly supports LAMC Sec. 41.18 which has been effectively implemented in Council District 11 and other areas of Los Angeles to protect public health and safety and preserve the use of public spaces for all constituents.

The Sun Valley Area Neighborhood Council, SVANC, in its regular meeting of September 10, 2024, passed the following community impact statement by a vote of: ? yes, ? no, ? absent, ? recused, and ? ineligible.

The use of artificial turf used to be considered a way to save water in a region where droughts have been experienced. Recent findings have shown that artificial turf cannot be recycled, it kills off any biodiversity beneath the turf, and creates exposure to PFA's. While drought resistant grass is an alternative, one must consider that the LA 100 plan will triple the LADWP rate payer's utility bill. This means that homeowners might need to choose between having a welcoming backyard for pets and family to play in or keeping it all dirt.

In order to have a more affordable water bill, many people may opt to put all cement which will decrease the amount of permeable land that would be exposed which in turn would decrease the amount of water that replenishes our ground water system.

The SVANC Board supports Council File 24-0602 only if amended to include the recommendations by the Climate Reality Project. Not only does artificial turf have PFAS and pollute ground soil beneath the turf, but it also suffocates surrounding trees just to name a few of the impacts artificial turf has on the community.

In addition, we urge you to consider providing rate payers deep discounts on water bills in addition to rebates for getting rid of their turf and replace it with more environmentally friendly alternatives.
