- A community member was bothered by the way the Tiny Homes Town Hall on August 7 was held. She felt that people were not given the opportunity to speak and their rights had been violated. She stated that misappropriation of funds was currently taking place. She encouraged all attendees to exercise their right to vote and that the neighborhood council create events to get people registered.
- Ricardo Benitez shared that he is a candidate for State Assembly for District 40. He shared that he was present at the town hall and that there were many discrepancies.
- A third community member spoke of her discontent with the Tiny Homes Town Hall. She stated that she went directly to a City Council meeting to speak about all the hardships the community is going through with not being able to pay for food, medical bills, pets' medical care, and utilities bills. She stated that she does not support the Tiny Homes project.
- Lionel Mares spoke on an item in the agenda he did not agree with and cautioned the board members of giving a single board member too much power

This new ordinance will help minimize parking issues for those who save the front parking by leaving their trashcans out at all times. Roll call vote was taken and the motion failed with 6 votes against, 2 in favor and 1 abstained.
