If you wish to Raise your Hand to address the board, press \*9 and the moderators will ask you to speak. You will be identified by the last 4 digits of your phone number.

### TO JOIN THE MEETING VIA SMARTPHONE APP (ZOOM):

**Instructions to join this meeting via a Smartphone app (recommended)**: You must download the **Zoom app** on your smartphone (iPhone and Android) to participate.
