### **ITEM 3: Public Comment**

- Mr. Mark Mardirossian, Mr. Mike O'Gara, Mr. Lysander Cuevas, Ms. Monica Vacas, Mr. Gary Aggas, and Ms. Wendy Thum made comments to the board.

## ITEM 4: Report of the Finance Committee Discuss budget for 2014-2015

- Mr. Mark Mardirossian gave the finance report.
- Mr. Mardirossian discussed the Budget Draft for fiscal year 2014-2015 approved by the Finance Committee on May 1, 2014, and asked for suggestions before sending it to the full Board.
- Mr. Mark Mardirossian, Mr. Mike O'Gara, Mr. Lysander Cuevas, Ms. Monica Vacas, Mr. Gary Aggas, and Ms. Wendy Thum participated in the finance discussion.

### ITEM 3a: Public Comment - REOPENED

- Public comment was reopened due to the arrival of Ms. Vicki Burch at 6:52 pm and Officer Jason Duplantis at 6:59pm.
- Ms. Vicki Burch addressed the board asking for support of the LAPD Foothill "Jeopardy" program, helping at-risk youth.
- Officer Jason Duplantis addressed the board offering statistics on the Jeopardy program and detailing what was needed in terms of support. He noted that 10 of the 36 kids in the program now are from Sun Valley.
- Ms. Vicki Burch addressed the board, announcing an upcoming "Tips for Kids" fundraising event at Bob's Big Boy May 28<sup>th</sup> where volunteer LAPD officers would serve the public and the tips and a percentage of the check would be donated.
- Discussion between board members and the public about quality, branding, and methods of finance ensued.
- Ms. Monica Vacas complimented GraffitiBusters for cleaning the area around Bob's Big Boy.
