ITEM 4A: Dan Rosales Jr., Planning Director with the Office of Councilmember Richard Alarcon on behalf of the SFV Veterans Day Parade Committee will speak regarding the 7th Annual San Fernando Valley Veterans Day Parade.

- Mr. Rosales announced that the Veterans Day Parade will be held on Thursday, November 11, 2010 in honor of the veterans from all branches of the Armed Forces. He added that Admiral Michael g. Mullen, U.S. Navy, Chairman of the Joint Chiefs of Staff will be the 2010 Grand Marshal.
