- ITEM 1: Call to Order, Pledge of Allegiance, Code of Civility, Roll Call
 - Gary called the meeting to order at about 06:30 pm
 - Gary lead the Board and all in attendance in the Pledge of Allegiance and SVANC's Code of Civility
 - Gary took roll
- ITEM 2: Opening Remarks & Seating of the New Governing Board of the Sun Valley Area
 - > Gary, as the outgoing SVANC's President, stated on the record, the following projectsthe current Board had been working on:
 - A Park Improvement at Fernangeles installing a Shane's Inspiration Jungle Gym, which is a recreation type outdoor's gym to allow access to young visitors, especially those with special needs. Design ideas are currently being solicited from stakeholders.
 - ➤ Gary stated that about 3 more Parks will be completed within the next few years. These are the Skate Park, the Cesar Chavez Park, and the County Park located on Strathern and Tujunga officially known as the Strathern Pit, that is designed with a Water feature to reclaim water to allow it to replenish water to the aquifer.
 - > SVANC's members have been working diligently, as volunteers, on the homeless issue around Sun Valley Park. The 3rd census will be conducted in January 2013 and volunteers to participate in the census count are welcomed.

- ➤ Gary added that about a year ago, a very successful Citizenship workshop took place, and stated that CHIRLA organization will hold a Citizenship workshop in August 22, 2012---registration for this workshop will be held at Holy Rosary Church.
- ➤ Gary stated that volunteers from North Hollywood and North East NC areas assisted SVANC with its elections, and they are asking for volunteers from SVANC to assist them in their election in two-hour shift periods, which will be held on September 20th, 2012.
- Mike stated that for the At-Large category board position, two additional members received 8 votes each, therefore a decision has to be made as to which candidate will qualify to fill this At-Large candidate position, which qualifies you if you are a member of an organization in Sun Valley ---such as a religious institution, Chamber of Commerce, PTA, or any other existing organization in Sun Valley.
 - Gary introduced Grayce Liu, the Interim General Manager from the Department of Neighborhood Empowerment (DONE), who swore-in the new SVANC's board members.
 - Ms. Liu administered the swearing-in of SVANC's complete new Board of Directors.

- Mr. Bill Hackett, CD2 representative, introduced himself as the new CD2's field deputy

- > Tania Oronoz, CD6 representative, announced the following:
 - On 07/24/2012 the City Council approved the ban of medical marijuana dispensaries in the City of L.A, and the ordinance was signed by Mayor Villaraigosa on 08/01/12. The marijuana dispensaries must close effective September 6th, 2012.

- CD6 staff met with representatives from LADWP to request extra lighting off Lankershim Blvd & San Fernando Road; as a result of this meeting and to date, LADWP has recently installed, upgraded and/or fixed Utilitarian lights in the area.
- CD6 staff met with Foothill Division officers to discuss the increase of prostitution activity off Lankershim between Stagg and San Fernando Road. CD6 staff in collaboration with Foothill Division's officers will conduct community walks to discourage criminal activity in Sun Valley along Lankershim/Strathern/Webb intersections. Ms. Padilla announced that this item will be heard in City Council on August 29th, 2012, at 2:00 pm.
- Ms. Padilla also mentioned that she attended an MTA meeting and was informed that in the next couple of weeks they will send emails with updates on the Sepulveda/Van Nuys rail being proposed for the East Valley.

- **ITEM 15:** Discuss the correspondence about the \$3.2 Million Dollar Bridge on Arleta Ave.
 - No new information presented
- ITEM 16: Discussion of the items on the last Planning Committee Agenda:
 The Ratner Recycling Center at 10970 Ratner St., Sun Valley CA 91352
 DORA'S Night Club Nuisance Abatement Proceedings and the upcoming hearing date of July 6, 2012.
 - ➤ Ms. Vacas said that the owner of the property where Ratner Recycling Center is located, attended the PLUM committee meeting and presented an option to place a container on this site, which will improve the area.
 - Ms. Vacas stated that she was not able to attend the meeting regarding Dora's Night Club, but Officer Esther Vasquez attended the meeting and will give a report when she returns
 - ➤ Mike stated that there are about 3 Pawn Shops in Sun Valley; the one that opened on Roscoe was presented to SVANC's Board about 1 year ago and the board wasn't in opposition.
 - ➤ Mike also added that the 7-11 representatives that opened on Roscoe and Lankershim did get a permit for beer and wine and will be open 24 hours; SVANC's board was not in opposition to this store because it's located in a commercial zone and is not near any residences.
 - ➤ Mike added that another that representatives of another 7-11 on Rincon and Sheldon has presented an application and are asking to sell beer and wine and to be open 24 hours; however, SVANC's board is in opposition because it will be located approximately 160 feet from the nearest residence.
- ITEM 17: Discuss Letter regarding the SVANC Planning and Land Use Committee position on CASE# CPC-2003-1038-CA & ENV-2003-1039-CE with regards to the Development of 91 units for Senior Independent and Assisted Living Care Housing Facility and its possible health hazard condition this could represent to the elderly residing at this facility. These planning Items on agenda are subject to Discussion and Possible Action
 - Mike said that this is a tiny lot on Jerome off Laurel Canyon and it is backed-up against the freeway right next to the off-ramp, the contractor currently has a permit to build a building with 26-condo units, but instead they want to change it to construct 91 units for senior living. Mike added that SVANC is opposed to this project due to the health risks of vehicle emissions due to the proximity of the proposed building to the freeway.
