SPECIAL MEETING For BOARD ORIENTATION

ITEM 1: Call to Order, Pledge of Allegiance, Roll Call_

- Mr. Mike O'Gara, President, officially called the meeting of Sun Valley Neighborhood Council to order at 06:47pm
- The Pledge of Allegiance and SVANC's Code of Civility were recited
- Mr. Mylo Koenig, Secretary, took roll

ITEM 2: Opening Remarks

• Mr. Mike O'Gara made opening remarks.

ITEM 3: Instructions on the LA City Rules and Regulations governing Neighborhood Councils--- Instructor Melvin Cañas

- Mr. Melvin Cañas of EmpowerLA conducted board orientation.
- Mr. Cañas discussed the "Sunshine Act" (an NC version of the Brown Act) and its movement through the California legislature
- Mr. Cañas made suggestions on how the SVANC board may consider handing Committee meetings to accommodate larger groups of members
- Mr. Cañas said that new Bylaws amendments are not being accepted at this time due to staff being concentrated on the NC elections. Amendments should be accepted again starting in July.
- The board member roster should be sent the the secretary to rosters@empowerla.org. Those are handled by Mr. Stephen Gluck.

- Mr. Cañas discussed the pros and cons of stakeholders being voting members on committees.
- Alois Phillips is the City Attorney working with neighborhood councils.
- Voting disclosure as a way to avoid conflicts of interest was discussed, and when it is appropriate to recuse itself. It was noted that the SVANC does not allow abstentions.
- PRA requests must be sent to Mr. Cañas right away due to time limits in responding.
- Meeting place requirements were discussed (must be ADA compliant for instance)
- Mr. Cañas noted that the SVANC Bylaws, regarding the election process, lack a definition of an Alternate. Other NC's have differing ways of determining Alternates.
- The Congress of Neighborhood Councils has training yearly in the last week of September. It is very useful to attend and members can learn a lot.
