ITEM 1: Call to Order, Roll Call, Pledge of Allegiance, Code of Civility

- Mr. Gary Aggas, President, officially called the meeting of Sun Valley Area Neighborhood Council to order at approximately 6:40pm
- The Pledge of Allegiance and SVANC's Code of Civility was recited
- Mr. Mylo Koenig, Secretary, took roll
- At 6:43pm, 17 board members were present. Quorum was met.
- There were approximately 20 members of the public present

ITEM 2: Opening Remarks

- Mr. Aggas requested of everyone present to please abide by the Code of Civility during the meeting
- Mr. Aggas announced that DONE/EmpowerLA approved SVANC's bylaws. Copies of the new SVANC Bylaws and the current Standing Rules were provided to all Board members and additional copies were placed up front for the public.

- Mr. Aggas said that the two open board seats, under the categories Senior and Resident, are still vacant, and the deadline to apply to be considered at next month's meeting is Tuesday, October 6th at 5:00 pm.
- Mr. Aggas stated that the Neighborhood Congress will be held on Saturday, September 26, 2015, at downtown L.A. City Hall
- Ms. Cindy Cleghorn of the Sunland Tujunga NC is trying to organize an Ethics training course at the Neighborhood Congress. For those who need the required training and want an inperson option, or if anyone needs information or guidance on any aspect of Ethics training, please contact Mylo Koenig.

ITEM 3: Emergency Personnel from Fire and Police Departments

- Senior Lead Officer Vasquez and Senior Lead Officer Wall
- Officer Vasquez announced the following:
 - 'Operation copcicle' took place at an elementary school in Sun Valley where about 250 big stick popsicles were distributed out of a black-and-white patrol cars to kids as they got out of school in an effort to establish a positive rapport. This has been done at three different schools in Sun Valley.
 - The benches at Sun Valley Park have been removed
 - There are plans to get the flag pole restored, and the SVANC was asked for possible assistance with this
 - o A couple of burglaries took place at two businesses on Sunland Blvd.
 - o Inform the LAPD if any marijuana dispensaries open or re-open in the area
 - LAPD Boosters golf tournament will take place on Friday, October 16, 2015. This
 event raises funds to purchase needed police equipment.
- No comment from Officer Wall

ITEM 4: Announcements from elected officials or their representatives

- Ms. Ruby Chavez, LAUSD Board member Monica Ratliff's new Chief of Staff, shared the following:
 - o The LAUSD School Board is in the process of searching for a new Superintendent
 - o Ms. Chavez' email is: ruby.chavez@lausd.net
 - Due to a partnership with the non-profit organization Rainbow Pack, backpacks and school supplies were distributed to every pre-school to 5th grade student at Roscoe Elementary School, along with three other elementary schools
 - o Roscoe Elementary School hosted its 3rd annual Starry Night Event. The school board member's office was able help the school get a solar sky dome.
 - The school board approved a critical repairs funds project to upgrade the floor and the walls of the main gym at Polytechnic High School. Construction will start the first quarter of 2016.
 - The school board approved a contract for architects to design two new science labs and a chemistry work room for Sun Valley Magnet School. The construction will start in 2016.
 - The school board approved funding to replace Sun Valley High School's digital marquis
 - 'More-than-a-Meal' campaign applications have been distributed to the schools. This is a Federal and State funded program that provides funds to the schools for each child that qualifies for free or reduced cost meals. The funds will also be used to hire more teachers, lower class size, additional nurse days, for various after school programs, classroom resources, etc.
 - The L.A. Chamber of Commerce has a 'Principal for a Day' program taking place on October 16, 2015 to try to encourage a closer relationship between business leaders and educators. For more information, visit www.lachamber.com/pfad
 - Per public comment, Ms. Chavez will look into the cell phone usage policy for LAUSD students under normal circumstances and during emergencies
- Mr. Caesar Huerta, Field Rep., CD-6 Councilmember Martinez, stated the following:
 - Sun Valley Neighborhood Pride Day will take place on Saturday, September 12, 2015 from 08:00am to 12:00 noon. Sanitation services, waste bins, ice and water will be provided. 150 volunteers have signed up, but more are needed and welcomed.

- A hearing will take place regarding La Vida Night Club on Thursday, September 17, 2015, 09:30am at the Board of Police Commissioners. This night club is asking for a permit to operate. Councilwoman Martinez is against issuing a permit for this night club.
- There is a neighborhood prosecutor for illegal dumping issues; her name is Susan Chung.
- Ms. Lorraine Diaz, Field Rep., CD-2 Councilmember Krekorian, announced the following:
 - L.A. City has opened up a number of cooling centers, i.e. public facilities, in the community during this heat episode
 - The L.A. County has scheduled ground spraying for a particular exotic fruit fly in this area of the Valley for the next month or so
 - Ms. Diaz announced a Neighborhood meeting at De Garmo Park, Friday, September 18, 10:00am
 - o The September monthly Councilmember's 'Lunch with Paul' meeting will be held at the Republic of Pies in midtown North Hollywood on Magnolia near Lankershim
- Mr. Nelson Pichardo, Consultant to Assembly member Patty Lopez, District 39, introduced himself and stated:
 - The Palmdale to Burbank segment of the California High Speed Rail will be passing through the Sun Valley area
 - o Assemblymember Lopez is sponsoring another community meeting regarding this topic at Fernangeles Park Community Center on September 26th, 2015, at 02:00pm
 - Assemblymember Lopez will be voting on over 1,000 Bills. Mr. Pichardo encouraged the public to contact her to voice public opinion and suggestions before she is to vote on these Bills.

ITEM 8: Committee Reports

- Outreach: Ms. Bille stated that the Sun Valley Neighborhood Pride Day is being promoted by the SVANC Outreach Committee
 - Ms. Bille said that a Citizenship Workshop will take place on Saturday, September 26,
 2015 at the 'Our Lady of the Holy Rosary' church.
- Beautification: Ms. Thum said that the vests are being printed with SVANC's logo for future clean-up events in CD's 2, 6 and 7. Ms. Thum said that they have been working on addressing the illegal dumping problem with different City Departments. Ms. Thum said they are organizing the Sun Valley Neighborhood Pride Day event to be held on Saturday, September 12, 2015.

ITEM 11: MOTION/DISCUSSION/VOTE to approve the letter regarding the Grocery Outlet's application for a liquor license

- Ms. Dueñas motioned to open the Item, seconded by Mr. O'Gara
- The motion was on the floor for discussion and a vote
- A motion was made by Mr. O'Gara to include in the letter addressing the CUP (Conditional Use Permit), the following three items: 1) We request that the single serve beer sold at this store will be non-refrigerated; and 2) we request that distilled spirits and wine will not be sold in containers smaller than 750ml; and 3) no advertising in the store window for alcohol sales; this motion was seconded by Mr. Aggas
- After opening remarks by Mr. Allen Lynch, president of DPI, property owner where the old Ralphs store was located and where Grocery Outlet is considering to lease (he later stated that he was also authorized to represent Grocery Outlet), followed by remarks by Mr. O'Gara of the SVANC Planning & Land Use Committee for which he expressed the Committee's overall support for the project, he introduced the above motion to request conditions for single-serve alcohol sales.
- --(At 8:35pm, Mr. Aggas motioned to extend the meeting by 30 minutes, seconded by Ms. Vacas. The motion carried 17/00)--
 - There was extensive discussion including board members and members of the public expressing various concerns about the restrictions in the motion to be included in the letter. Mr Lynch stated that due to the competitive nature of the grocery business, if Grocery Outlet could not offer full service or had to operate under any conditions, this might influence their decision to move into this location.

- During the discussion a general sense was imparted by Mr. Lynch that there were sufficient controls in store operation that could preclude the issues that trouble other types of retail establishments such as liquor stores
- Mr. O'Gara noted that after a Planning meeting agreement not to advertise alcohol sales in the store window, that he went downtown to examine the application and found artwork for window advertising of alcohol.

--(At 9:01pm, Mr. Aggas motioned to extend the meeting by 30 minutes, seconded by Ms. Sower. The motion carried 16/01 [Khalaf opposed])--

- After consideration of remarks by Mr. Lynch, the public, and other board members, Mr. O'Gara amended his motion to drop the first item, and include only items 2 and 3 in the letter (as amended: "We request that distilled spirits and wine will not be sold in containers smaller than 750ml; and no advertising in the store window for alcohol sales.") Mr. O'Gara's amended motion was seconded by Mr. Aggas.
