# ITEM 1: Call to Order, Roll Call, Pledge of Allegiance, Code of Civility

- Mr. Gary Aggas, President, officially called the meeting of Sun Valley Area Neighborhood Council to order at approximately 6:35pm
- The Pledge of Allegiance and SVANC's Code of Civility was recited
- Mr. Mylo Koenig, Secretary, took roll
- At 6:36pm, 11 board members were present. Quorum was met.
- There were approximately 22 members of the public present.

## ITEM 2: Opening Remarks

- Mr. Aggas asked if Mr. Culley and Ms. Vacas had updated their Ethics certification
- Mr. Culley said he will soon, and Ms. Vacas will provide information
- Mr. Aggas stated that there is one open Board seat available under the Senior category (age 55 or older) for anyone that needs to live, work, own property, or have a business in Sun Valley, and he/she needs to apply by Thursday November 3<sup>rd</sup>, 2015.

#### **ITEM 3**: Emergency Personnel from Fire and Police Departments

- Senior Lead Officer Vasquez and Senior Lead Officer Wall announced the following:
- Officer Vasques gave the following update
  - Sun Valley's overall crime rate is down
  - The "copsicle" popsicle give-away continues at local schools, including Glenwood and Roscoe Elementary Schools. The LAPD Foothill Division's goal is to distribute candy canes to the local schools for Christmas
  - LAPD submitted its opposition to the End Zone for their ABC license
- Officer Wall announced the following:
  - o Eight homes have been hit with attempted mail theft on Sunland Blvd.
  - o Last Saturday on October 10<sup>th</sup>, a Neighborhood Watch meeting took place where it was announced that a newer red Dodge truck has been seen in the neighborhood, where one person is dropped off who checks mailboxes while the driver waits for him/her down the street. If you see such activity, please report it by calling 911. This and similar incidents most likely has to do with identity theft.

# ITEM 4: Announcements from elected officials or their representatives

- Mr. Nigel Sánchez, Aide to Congressman Cárdenas, gave the following update:
  - There is a Media Advisory stating that on September 28<sup>th</sup>, the Congressman introduced the PACE (Protecting Affordable Coverage for Employees) Act--Bill HR1624. This Bill passed unanimously in the House of Representatives and on October 5<sup>th</sup>, the Senate passed the PACE Act, and now it's waiting to be signed by the President. When signed, this Act will protect small employers from increased regulations and allow the employees to keep their current health insurance plans.
  - o On October 24<sup>th</sup>, there will be a Foreclosure Prevention Resource fair
  - There will be a Veteran's Day forum on Nov. 11<sup>th</sup>, at Byrd Middle School in Arleta.
  - Mr. Sánchez introduced State Senator Robert Hertzberg
- Senator Robert Hertzberg stated that on November 22, there will be a first time San Fernando Valley forum to talk about issues that affect the San Fernando Valley.
- Ms. Lorraine Diaz, Field Rep., CD-2 Councilmember Krekorian, stated the following:
  - Next month there will be a 'meet with Paul' event, date TBA
  - The councilmember proposed a motion to tax gun sales and ammunition
  - o Call Ms. Diaz if you have issues about re-pavement of a street in your neighborhood
  - Ms. Diaz announced a Halloween clean-up in Sun Valley on Saturday, October 31<sup>st</sup>, 08:00am-11:00am, at Sun Valley Magnet School. The SVANC is a co-sponsor.
- Mr. David Gonzalez, Education Deputy for Board member Mónica Ratliff at LAUSD, stated the following:
  - The Board has begun the process to hire a new LAUSD Superintendant. There will be community forums; one will be at Byrd Middle School on October 20<sup>th</sup>, 10:00am
  - New applications are due October 23<sup>rd</sup> for students who are eligible to receive free or reduced-price lunches
  - The Magnet application deadline is November 13<sup>th</sup>, you can fill out an application by visiting <a href="mailto:echoices@lausd.net">echoices@lausd.net</a> or you can pick up an application from your local school
- Mr. Caesar Huerta, Field Rep., CD-6 Councilmember Martinez, stated the following:
  - Congratulations to the SVANC Council for the Sun Valley Neighborhood Pride Day. A certificate was presented to SVANC's President from CD-6.
  - For illegal dumping, please call Officer Vasquez or Officer Wall or the CD-6 office
  - The Councilmember re-established a surveillance program throughout the City for illegal dumpers
  - Senior Programming has been started at Fernangeles Park, in a partnership with Kaiser to create a walking program to encourage seniors and everyone else to join in and exercise at Fernangeles Park
  - There is new legislation to ban the parking of oversized vehicles including RVs on all residential streets citywide

- Mr. Jason Shepherd, facility director of Fernangeles Park, introduced Daniel Hernandez, his new recreation coordinator, and thanked the SVANC for its support at the Halloween event for the 'Day of the Dead' (dia de los muertos).
- Daniel Hernandez, Recreation Coordinator at Fernangeles Park, introduced himself.
