ITEM 1: Call to Order, Roll Call, Pledge of Allegiance, Code of Civility

- Mr. Gary Aggas, President, officially called the meeting of Sun Valley Area Neighborhood Council to order at approximately 6:30pm
- Major John Wells, from the North Valley Military Institute College Preparatory Academy, in Sun Valley, led the Color Guard in honor of Veterans' Day.
- Major Wells invited everyone to their Veterans' Parade to be held on Friday, November 13, at 08:00am, guests are encouraged to enter the school through Allegheny.
- The Color Guard led the Board and public in reciting the Pledge of Allegiance
- SVANC's Code of Civility was recited by the Board
- Mr. Mylo Koenig, Secretary, took roll
- At 6:31pm, 13 board members were present. Quorum was met.
- There were approximately 20 members of the public present

ITEM 2: Opening Remarks

- Mr. Aggas asked if Mr. Dahlquist and Ms. Housden had taken/updated their Ethics certification to enable them to vote on Funding Items at this meeting, neither had. Mr. Aggas then offered his and Secretary Koenig's assistance to these members in order to become current with the Ethics certification.
- Mr. Aggas announced that there is one Senior seat open on the Board. Interested persons needs to apply by Thursday, December 1, 2015, by 05:00 pm.

ITEM 3: Emergency Personnel from Fire and Police Departments

- Senior Lead Officer Vasquez (present) and Senior Lead Officer Wall (not present)
- Senior Lead Officer Esther Vasquez stated the following:
 - o Crime is up by about 13% in the Foothill Division; Sun Valley crime is down about 2%
 - The holiday season typically shows an increase in crime stats, so Officer Vasquez asked everyone present to please be vigilant and not leave any valuables in the car in full view, and to lock their car and house doors.
 - Officer Vasquez also warned everyone present about fraud crimes. She stated that fraud is appearing in many forms, like phone calls, paying money to get a job, emails—national and internationally, in person knock-on-you-door scams, etc.
 - There have been two reported 'fake' kidnappings. The Officer said if anyone gets this type of call, please call 911 from another phone because usually the so called 'kidnappers' are on one phone.
 - The Officer said that they served search warrants at two marijuana clinics in the last month, both of which were in Sun Valley.
 - The prostitution problem is being monitored closely by the LAPD, especially over the weekends in the community and at the truck stops.
 - o Any motor home activity, especially long term stay, should be reported to the LAPD.
 - A toy give-away will be held at Fernangeles Park, Saturday, December 5th, from 10:00am to 02:00pm, for ages 10-13.

ITEM 4: Announcements from elected officials or their representatives

- Mr. Nigel Sánchez, Aide to Congressman Cárdenas, stated the following:
 - The Congressman is hosting his Annual Veterans' Day forum on Wednesday,
 November 11, 2015, at Byrd Middle School, 04:00pm 07:00pm
 - A health care fair will be held on November 21st, where free health services will be available for the attendees, at Branford Recreation Center, 10:00am-01:00pm
- Ms. Lorraine Diaz, Field Rep., CD-2 Councilmember Krekorian, announced the following:
 - She thanked SVANC's board members and attendees for their participation at the clean-up two weekends ago.
 - The LADWP will hold a community meeting on Thursday, November 12, 2015, regarding the proposed rates increase, 06:00pm, at North Hollywood Amelia Earhart Regional library; and on Saturday, November 14 at Van Nuys City Hall.
 - o The LAPD is holding a community forum on December 3rd, 2015, called "The Days of Dialogue," at the Alicia Broadous Community Center in Pacoima
 - o Flyers were distributed with emergency numbers related to El Niño events
- Mr. Caesar Huerta, Field Rep., CD-6 Councilmember Martinez, stated the following:
 - o CD6 is having a community clean-up on Saturday, November 14th, 2015. Mr. Huerta thanked SVANC for sponsoring the breakfast and lunch for the day of the clean up.
 - o Mr. Huerta thanked Poly HS, specifically Mr. Rene Novoa and Mr. Bennett for being great partners during the clean-up event.
 - Officer Vasquez mentioned that the LAPD along with the Councilwoman's office will hold an Operation Valley Girl Human Trafficking Task Force meeting on Thursday, November 19th, 2015, at Van Nuys City Hall, on the 2nd Floor, at 06:00pm, in response to the high demand of information regarding this issue. This request will not only benefit CD6, but the whole Valley, which has several tracts that have been known for having human trafficking and prostitution activities.
 - Regarding the sidewalk repair program, due to a lawsuit against the City, it was ordered that the City has to start fixing its sidewalks. Due to this lawsuit, the City now allocates \$30 million dollars per year for up to 30 years for this purpose. The allocation of these funds is still being vetted in Committee.

- Mr. David Gonzalez, LAUSD's Education Deputy for Mónica Ratliff, invited the community to Poly HS, Monday, November 16, 2015, 06:00PM, to a meeting regarding Local Control and Accountability Plan (ALCAP). Mr. Gonzalez introduced Principal Ari Bennett.
- Principal Ari Bennett, Polytechnic High School in Sun Valley, introduced himself and announced the following:
 - Thursday, November 12, 2015, 07:00 pm, a special community meeting will be held for the Modernization Project at Poly HS.
 - Mr. Bennett stated he is a candidate for the LAUSD Superintendent position.
- Mr. Greg Bartz, LADWP's Community Liaison, stated the following:
 - o He is available for questions regarding billing, account issues, rate increases, etc.
 - He announced a number of upcoming community meeting dates regarding the rate increases and encouraged the public to attend these meetings in order to have their voices heard on these issues
 - o He discussed a 'Water Assessment' for construction projects.
 - o He talked about the Rain Barrel rebate program
 - o He recognized the clean up area between Arleta and Laurel Canyon on Sheldon
