SLO Vasquez, LAPD, SLO Wall is off this week. 64% increase in auto burglaries for the area. Remember to lock your vehicles. Great clean-up last weekend with the HOPE team working the area with sanitation. A RV caught fire under the bridge. RV body was crushed and hauled away,

but the chassis will remain until next Friday when the heavy tow contractor can take it away. Caltrans will be cleaning their side of the fence next week. Thank you to SVANC for the snacks provided for the clean-up.

• Captain Brian Azure, LAFD, recently promoted to Station 77 and was introducing himself and his crew. If you have any questions or concerns, call the station or knock on the door.

ITEM 13: BRIEF Presentation/Announcements from elected officials or their representatives

- FD Franklin Ochoa, ASM Bocanegra, congratulations to the new Executive Board. AB332 which will vacate streets due to illegal dumping has passed in committee and will move to the assembly floor. Reports of graffiti on the SR170 were cleaned up two weeks later. Encampments will be handled through an online, process service request to get services to the homeless and/or enforcement for the Caltrans properties.
- FD Caesar Huerta, City Council Nury Martinez, Last month reported on BoSS resurfaced 30th Street in Sun Valley. City Hall Council staff is working hard to get the allocated funds for more resurfacing in the district. We are seeing the consequences of the parking restriction 8502 dwelling in vehicles. As the law is being enforced, bulky items are being left when the RVs leave. CM Martinez is asking for a CIS to address the increase of parking restrictions for the area. If you see a DOT parking violation in progress call 818-374-4823.
- Barry Stone, NEA, DONE, Contact Funding for information on paperwork for the new treasurer and card holder. Remember to take your funding training and ethics as some Boardmembers need to renew. Funding is now with the City Clerk's Office and deadline for the P-card and funding requests have changed. June 1st is the last day for funding requests and online banking closes June 7th and will not be available until July 1st. P-card purchases deadline is June 11th. DONE is accepting applications for Civic Youth Leadership 101 from persons 14-24 years old. Deadline to register is May 24th and anyone interested can register at www.empowerla.org. - Rosemary Duff, LAUSD, May 20th 100th anniversary for Vinedale from 11-3. National Library Week. Monica Ratliff has sponsored a resolution for students to read more and explore the world through library resources and to fund \$1000 for library books for all schools in the district. 2300 students from 2 dozen schools recently gathered at Poly High School to interact with NASA and some of the current programs they are working on.
- Fornado Tapia, Poly High, preliminary plans for the update of the campus. Meeting next Thursday for the presentation of the \$100M modernization plan for 11 schools including Poly. There are three different concepts and the district is looking for community input.
