ITEM 6: GENERAL PUBLIC COMMENT ON NON-AGENDA ITEMS which are within the Board's subject-matter jurisdiction (comments only, no discussion).

Louis Bolanos – He is concerned with articles he read from the New York Times regarding the problems North Carolina is going through with having no flood insurance and how this will become a total dependence on the federal government. This should bring concerns as Los Angeles has a whole series of issues about sustainability. He handed out yellow envelopes with copies of the article to all Board members. He also shared concerns regarding the bird flu and how he has not heard about what the County is doing about it. He is also concerned with lowering the number of cars on the roads and how the Mayor is not addressing that.

Rosie Perez from the Fernangeles Recreation Center introduced herself and Michelle Sanchez and invited all to the Halloween event on October 25 from 4:30 pm to 8:30 pm, asked for volunteers and candy donations

Jillian Burgos introduced herself as candidate to council district 2 with her platform running on expanding public transportation, expanding green spaces, making housing a human right and implementing unarmed crisis response

Lionel Mares, Region 1 Budget Advocate – Expect to receive monthly reports. The budget advocates will be meeting with City departments to discuss their budget proposals and with City Council.

Richard Serrano – Thanked Ms. Chávez and SVANC. Asked that RVs be removed from our areas. Dodgers are losing six to one. He is here to show his support to Council member Imelda Padilla regarding the removal of RVs. There is a financial crisis. The City Controller has already said they will not make the fiscal year budget of June. He asked that SVANC prioritize what they do with the money given to them. The City needs to prioritize our money. To me the priority is the homeless and the hungry.

Gibson introduced himself as a representative from Assembly candidate Celeste Rodriguez and invited the community to a Meet and Greet at Panda Express at 3:30 pm

ITEM 7: Board Member Comment on matters within the Board's subject-matter jurisdiction that DO NOT appear on the agenda (comments only, no discussion).

Norma Chávez shared that she was unable to attend the Summit of Council of Neighborhoods because SVANC already had a cleanup scheduled for the same day and time. She apologized for SVANC not being able to attend certain events they are invited to, but that is usually due to conflict of schedule from events already approved by SVANC months in advance.

For ITEM 8: The applicant will make his/her candidate statement. A brief question and answer session will be held after which, a vote will be taken. If appointed, the applicant will be seated on the Board and will have full privileges including the ability to vote, except on funding matters. The new Board member will then read the SVANC Code of Civility which will serve as the Oath of Office.

Ms. Chávez shared that the next three motions would be voted on as recommended by the City to make sure they have included in the current budget. The amount of the lease remains the same. ITEM 10: Motion / Discussion / Vote to approve a contract with Concept To Web LLC to provide the services of Aaron DeVandry for a twelve-month agreement, July 2024 through June 2025, to do the following: website hosting, website content creation, social media management, professional email management (this one is an additional fee paid directly to the email provider for an amount to be determined for the email account, not to Concept to Web LLC), maintenance of an event calendar, maintenance of a stakeholder email list, mass email blasts to stakeholders, website updates, online agenda posting, online minutes posting, creating Facebook Events for the NC events, online monthly expenditure report posting, newsletter, agenda combining – adding additional files to the agenda to result in a single file. The yearly fee shall not exceed \$1800. 1st - Rosalío García, 2nd – Eddie Venegas. Ample discussion took place and there were concerns from items changed in the website that SVANC truly needs as that is what constituents like and are used to receiving from SVANC such as the announcement of committee meetings with agendas via a mass email. Constituents have also shared that the agendas are not available in the website or they are difficult to find. SVANC should have no restrictions on the number of flyers shared in the newsletter and who they come from. SVANC should be able to share fliers from all elected officials. The verbal agreement between the executive board and the new webmaster was that he would charge between \$100 to \$150. The finance and executive committee decided on \$200 as a cushion for extra projects when there are more events or for the first two months when the webmaster had to redesign the website and transfer files. However, the webmaster has made it a monthly charge of \$200. There are still many concerns regarding the newsletter, mass emails, announcements, and agendas. Board members want to be able to change the webmaster if the needs of SVANC and the Sun Valley constituents are not met. Wendy Thum recommended amending the motion to include an escape clause so that we can get out of the contract if we are not satisfied with the work. Norma Chávez moved to amend item 10 to add a clause to cancel the contract if SVANC is not satisfied with the job performance and Cindy Valle seconded. It was unanimously approved. The new motion reads the same as the original motion, but the words "escape clause" has been added. Roll call vote took place and the motion was approved with 9 votes in favor and 1 ineligible.
